- Miller: Some faculty inquires regarding when collections will become available, 2 recent COVID cases reported.
- Dominguez: Supposed to return for test run on January 4 as faculty want physical access, and trying to stay in OL project, so will encourage faculty to use electronic version if they can. Whether or not being open will depend on the COVID numbers.
- Galvin: Only nursing/therapy and public safety on campus. Interlibrary loan/Access staff worried about books all over the place throughout the year.
- Arguelles: 2 cases reported last week.
- Dreyer: Interlibrary loan on limited basis; going day by day with how classes might be in spring.
- Kinyatti: On occasion staff going in to check the bin for returned materials.
- Information generally shared in chat: Information regarding Interlibrary loans, how campuses are setting up checkout/returns. People saying no one using computer labs, only study labs.
- Question is to how are libraries being staffed general consensus is mostly volunteers.

■ Discussion about what was cut from budgets at campuses. Several expressed concern regarding declining enrollments and fact students are unable to pay tuition under current circumstances. However, some campuses still turning in invoices that are getting paid. Comment that this might be yet another incentive for coordinated collection development.

- Committee has not yet been able to meet, but knows that the that ALMA Analytics group has had some meetings, so will look at that.

 - i) Diversity & Inclusion Task Force Drabinski 5 min.
- Committee would like to plan Spring event that would address lack of diversity / other forms of diversity among Chief Librarians, and how to have more diverse senior leadership at CUNY Libraries.
- Comment that it could be useful if there was some product regarding the scope of issue by looking to see if there's something from Central with the data and information.
- Comment that there might need to be some shared analysis among the CCL on how to discuss race issues.
- Comment also that might want to review CCL libguide to see if anything helpful there.
- Comment that there might have been a white paper a few years ago discussing this? Smale said there was, and she'd look for it.
 - 3) Office of Library Services Reports
 - i) Dean's Report Thistlethwaite 5 min.
- Thistlewaite's last meeting as Interim Dean, and thanked CCL for working with her. Last
- Report has list of open positions at OLS and what's available and potential plan for staffing. Wanted to share some transparency as to what was going on and to show that searches are underway.
- In last week, some movement to post Budget and Collections position; and verbal statement to post the metadata coordinator/cataloger position reporting to systems. Acknowledgement from Maruca that those are key positions. Also a move to reclassify a current OLS employee to recognize the work being done outside the scope

- or original job classification, and in recognition of employee doing more work with ALMA reports and analytics.
- Question regarding the job descriptions. Budget and Collections position just the BA required? Doesn't require MLS?
- Answer: Could be candidates in ScholCom or Open Journal publishing who don't have an MLS who might be good in the position. More heavily working with contracts and procurement and ScholCom to make us a more powerful engine of acquisitions.
- There were discussions regarding whether MLS or graduate degree preferred? Concerns? Can communicate to Maruca.
- Dean's Search is out. Question: Should we try to get an interim in the meantime, and could we get one if needed?
- Smale: Position posted Nov. 30; no second degree; pointed out again to Maruca. Smale told Central that with with reviews starting Dec. 9, outside folks would assume there was an internal candidate. Job search extended, so review will not start until at least Dec. 31. Smale asked folks to circulate widely. Unsure why CUNY is not using a search firm for the position. Some have not seen the job advertised anywhere. Some expressed concern regarding the fact the position does not required the second degree.
- Question: Should we try to create questions for CCL candidates? Answer: Agreed it might be a good idea when we get to that point.
 - ii) Library Systems Verbovetskaya 5 min.
- Submitted report.
- Nancy Egan / Kevin Collins both retiring. Acknowledged how different things will be without them.
 - iii) OER Fiddler 5 min.
- Those who were expecting money from OER should be in receipt of letters and money today.

- Looked at metrics around repository. In 2020 showed 50% increase in download vs. same time previous year. Submissions down 18% overall; then diverge when looking at content types.

- Report went out. Significant things in report, so please review.
- Egan made clear that for some databases, some are subscribed to by only a few campuses, which are separate from University wide subscriptions. However, when a campus has to pull out, there should be a discussion with Central regarding cancellation, so can try not to affect.
- Subcommittee of ERAC and Scholcom is working together.
- ACRL and IPEDS data collection starting up. CCL reminded that folks need to be appointed. Don't rely on memory that the deadlines have always been extended, there is a shorter timeline this time around. With other surveys, did backwards mapping, and urgent that everything gets done in January.
- Question: Has ACRL said explicitly they won't extend deadlines? Answer: What we see are differences in data/questions, with ACRL also communicating tight deadlines. Always tracking data from previous data data from ALEPH, not ALMA; data that didn't migrate being handled from OLS. There will still be a libguide where you look up your campus data, and IPEDS and ACRL are still going to track each other.

- Report that there are 318 students this semester; 75 full time; already have 80 applicants for Spring; one faculty member is going on travia in spring; retiring in August.
